

ORDINANCE NO. 819
AN ORDINANCE ADDING CHAPTER SECTION 10.08.250
OF THE SONORA MUNICIPAL CODE
DISABLE PERSON PARKING

The City Council of the City of Sonora does hereby ordain as follows:

Chapter Section 10.08.250 “Disabled person parking” will be added to the Sonora Municipal Code.

Chapter Section 10.08.250 shall read as follows:

10.08.250 Disabled-person parking

- A. It shall be unlawful for any person to stop, park, or leave standing (whether attended or unattended) a vehicle for any period of time in a stall or space designated for disabled-person parking, unless:
 - (1) The vehicle is currently displaying either a disabled- person license plate or a valid placard; and
 - (2) The vehicle, at that time, is operated by or used to transport a disabled person who is within a reasonable proximity of the car parked in a stall or space designated for a disabled person.
- B. It shall be unlawful for any person to obstruct, block, or otherwise prevent, or hinder access to disabled-person’s parking stall or space.
- C. It shall be unlawful for any person to stop, park, or leave standing (whether attended or unattended) any vehicle, for any period of time, including a vehicle displaying disabled persons license plates or a placard, in either of the following places;
 - (1) On the lines marking the boundaries of a parking stall or space designated for disabled persons.
 - (2) In any area of the pavement adjacent to a parking stall or space designated for disabled persons that is marked by crosshatched lines.
- D. This section shall apply to; all public off-street parking lots, all disabled-person parking stalls or spaces on City streets, any privately owned and maintained off-street parking lots, which are properly marked pursuant to 10.08.240.
- E. A violation of this ordinance is an infraction, punishable by a fine as set by the latest parking violation fine resolution.

This Ordinance will be effective thirty days after its final passage and will be published within fifteen days after its final passage as provided by law.
