SUBJECT: 2017 Volunteer Firefighter Assistance Grant

RECOMMENDATION:

- A.** That the City Council by motion accept the 2017 Volunteer Firefighter Assistance Grant Resolution #09-5-2017A in the amount of \$39,559.95
- B.** That the City Council designate the Fire Chief as the City's representative to sign the agreements on behalf of the City of Sonora Fire Department.
- C.** That the City Council authorize a budget adjustment in the amount of \$19,779.97 (the required City match for the grant) from the Measure I Fire Fund, Fund 404, fund balance.

BACKGROUND: Accepting the Volunteer Firefighter Assistance grant will allow the Fire Department to purchase Structural and Wildland personal safety equipment, fire suppression equipment and communications equipment at a 50/50 match with the Department of Forestry and Fire Protection.
