

BUSINESS LICENSE TAX/EXEMPT BENEFIT ZONE CHARGE CALCULATION

To calculate the appropriate amount due, complete the calculation section below. To determine the range your business falls within, calculate the number of employees as the actual number of employees on the payroll, rather than the equivalent number of full time employees. The total number claimed shall include the owner(s) of the business. If a business has no employees, and is thus operated by the owner(s), the total number of owner(s) shall be claimed.

The number of employees (including the owner(s)) for the annual fee shall be determined by the number of employees on the payroll for the period ended September 30th of the preceding year for which the fee is due.

Annual license taxes shall be due the first day of JANUARY of each year, and delinquent after JANUARY 31st.

*On October 11 2017 Governor Brown signed into law AB-1379 which amends the SB-1186 which adds a state fee of \$4.00 on any applicant for a local business license or similar instrument or permit, or renewal thereof. The purpose is to increase disability access and compliance with construction-related accessibility requirements and to develop educational resources for businesses in order to facilitate compliance with federal and state disability laws, as specified.

Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public.
