SUBJECT: 2018 Volunteer Firefighter Assistance Grant

RECOMMENDATION: That the City Council by motion accept the 2018 Volunteer Firefighter Assistance Grant Resolution #08-20-2018A in the amount of \$11,600.00 and that the City Council designate the Fire Chief as the City's representative to sign the agreements on behalf of the City of Sonora Fire Department. Funding will be from the general fund for the City's' matching funds of \$5,800.00.

BACKGROUND: Accepting the Volunteer Firefighter Assistance grant will allow the Fire Department to purchase Structural personal safety equipment at a 50/50 match with the Department of Forestry and Fire Protection.
