RE: TEMPORARY NO PARKING ZONES; 2019 MOTHER LODE FAIR

RECOMMENDATION:

Staff recommends the City Council pass and adopt Resolution Number 06-03-2019-A, authorizing temporary "No Parking" zones be established along certain City Streets during the 2019 Mother Lode Fair.

BACKGROUND:

Each year the Tuolumne County Mother Lode Fair is held at the fairgrounds located within the City limits of Sonora. This event results in a large amount of vehicle and pedestrian traffic around the fairgrounds. Because of the additional traffic, temporary "No Parking" zones are established to assist with the flow of pedestrian traffic, as well as to keep narrow streets open for emergency vehicles.

DISCUSSION:

The Mother Lode Fair will begin on Thursday, July 4th, 2019, and end on Sunday, July 7th, 2019. Because of the large volume of pedestrian and vehicle traffic around the fairgrounds, temporary "No Parking" zones are created to assist with the flow of pedestrian traffic, as well as to keep narrow streets open for emergency vehicles.

RESOLUTION 06-03-2019-A

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SONORA, CALIFORNIA, APPROVING TEMPORARY "NO PARKING" ZONES ON CERTAIN CITY STREETS TO ACCOMMODATE PEDESTRIAN, AS WELL AS VEHICLE TRAFFIC ASSOCIATED WITH THE MOTHER LODGE FAIR TO BE HELD THURSDAY, 4 JULY 2019, THROUGH SUNDAY, 7 JULY 2019.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SONORA THAT THE FOLLOWING TEMPORARY "NO PARKING" ZONES BE ESTABLISHED FROM THURSDAY, 4 JULY 2019, THROUGH SUNDAY, 7 JULY 2019.

1. There shall be no parking at the south/east corner of the intersection of State Route 49 (Stockton Road) and Southgate, in the area of the locomotive and crosswalk.
2. There shall be no parking on the east side of Solinski, between State Route 49 (Stockton Road) and West Jackson Street.
3. There shall be no parking on Fairview Lane, between State Route 49 (Stockton Road) and the driveway into the Tuolumne County Superintendents' Office.
4. There shall be no parking on the east or west side of Forest Road, between State Route 49 (Stockton Road) and the driveway into the Adventist Health Wellness Center.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Sonora that all of the above is hereby approved.
