SUBJECT: 2019 Volunteer Firefighter Assistance Grant

BACKGROUND: Accepting the Volunteer Firefighter Assistance grant will allow the Fire Department to purchase Wildland Safety Equipment, Structural personal safety equipment, safety flashlights, and updated radio equipment at a 50/50 match with the Department of Forestry and Fire Protection.

RECOMMENDATION: That the City Council by motion accept the 2019 Volunteer Firefighter Assistance Grant Resolution #09-16-2019B in the amount of \$26,496..22 and that the City Council designate the Fire Chief as the City's representative to sign the agreements on behalf of the City of Sonora Fire Department. Funding will be from the Fire fund 399 for the City's' matching funds of \$13,249.11.
