## **RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE, CALIFORNIA, IN SUPPORT OF RACIAL JUSTICE AND BLACK LIVES MATTER**

Findings

WHEREAS, the City of Pacific Grove (City) is committed to ensuring that its residents prosper and enjoy a sense of safety as they live, work and play in Pacific Grove; and

WHEREAS, that commitment extends to all residents regardless of race; and

WHEREAS, the tragic death of George Floyd in Minneapolis on May 25, 2020 at the hands of police officers ignited demonstrations across the country including the City on which demonstrators demanded justice for the deaths of Mr. Floyd, Breonna Taylor, Ahmaud Arbery, and far too many other Black Americans during encounters with police; and

WHEREAS, these deaths have sparked a national conversation about policing, systemic injustice, race and a recognition that that our country's promise of equity and justice remains unfulfilled for many Black Americans; and

WHEREAS, the City is listening to the demands of residents and protestors who are demanding that the City take action to change policies to prevent violent encounters with the police and modify practices to strengthen relationships between police and Black Americans, as well as all people of color in Pacific Grove; and

WHEREAS, the City recognizes that racism, not race, causes disproportionately high rates of homelessness, incarceration, poor education, health issues, including mental health, and economic hardship for Black and Brown Americans; and

WHEREAS, the City Police Department's policies and staff have demonstrated a commitment to positive policing in our City to include recent policing policy updates; and

WHEREAS, the City is actively reflecting and identifying how it can promote racial justice through concrete actions, policies and practices that dismantle systemic racism in order to bridge the gap between our values and reality; and

WHEREAS, the City commits to holding elected officials, public safety officers, and community leaders accountable for their actions to promote racial justice and ensure the promise of public safety and prosperity is accessible for all; and

#### RESOLUTION NO.

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO DENOUNCING THE DISCRIMINATION AGAINST THE ASIAN AMERICAN COMMUNITIES DURING THE COVID-19 CRISIS IN FRESNO

WHEREAS, the City of Fresno denounces the racial discrimination that Asian American communities have experienced in Fresno during the COVID-19 pandemic crisis. Asian American communities in Fresno, including but not limited to Cambodian, Chinese, Filipino, Hmong, Iu-Mien, Japanese, Khmu, Korean, Lao, Punjabi, Thai, and Vietnamese; and

WHEREAS, the City of Fresno will continue to celebrate the diverse communities that make up the City of Fresno, call on all communities to stand in solidarity with those affected by racial discrimination, and work courageously together towards healing and recovery; and

WHEREAS, the City of Fresno is partnering with local organizations to address the heightened xenophobia and anti-Asian incidents that have increased throughout the COVID-19 pandemic; and

WHEREAS, Asian American communities continue to be instrumental and pioneers in the City of Fresno since the 1860s. Today, Asian Americans make up Fresno's second-largest community of color. Asian American community members serve as advocates, attorneys, business owners, educators, farmers, health care providers, industrial and maintenance workers, public service providers, and active contributors to the City of Fresno; and WHEREAS, the COVID-19 epidemic has had a tremendous impact on all of Fresno, California, the United States, and globally; fear, decrease in mental wellness, and loss of economic security; and

WHEREAS, Asian American communities are faced with discrimination due to the stigma of COVID-19 and xenophobia including harassment, physical assaults, bullying, denial of service at local businesses, racial slurs, and damage to property; and

WHEREAS, since March 2020, Stop AAPI Hate, a national coalition aimed at addressing anti-Asian discrimination amid the pandemic and founded by the Asian Pacific Policy and Planning Council, Chinese for Affirmative Action, and San Francisco State University's Asian American Studies Department, has documented 3,800 reports of anti-Asian hate incidents, with the vast majority of incidents (68%) reported by women; and

WHEREAS, Asian American communities are concerned about their physical and mental wellness and seek a Fresno community of healing and recovery; and

WHEREAS, the City of Fresno will not tolerate acts of aggression and harassment towards any communities including Asian American communities; and

WHEREAS, the City of Fresno recognizes the COVID-19 pandemic does not discriminate and that all Fresnans are at risk of being infected by the virus; and

WHEREAS, in March 2020, Saeng Bunsy was buying diapers at a Fresno store when a woman told her to "move out of my way" and then used a racial slur; and

WHEREAS, on March 9, 2020, a Lao family's car was vandalized with "[F-word], Asions [sic] and Coronyvirus [sic];" and

WHEREAS, on January 18, 2021, a Hmong American man was physically assaulted while on his morning walk in Roeding Park. No money or belongings were taken; and

WHEREAS, on February 17, 2021, a Lao identified woman was threatened at the parking lot of Target at River Park, when a man pulled out his gun at her; and

WHEREAS, countless other incidents have been shared with trusted community partners, but there are limited linguistically accessible and culturally responsive ways to report hate incidents to the City of Fresno; and

WHEREAS, the targeted killings of six Asian women in Atlanta, Georgia, and the current events involving anti-Asian violence incite fear and a lack of safety in Asian communities.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The City of Fresno and supporting entities and community members, denounce the racial discrimination, white supremacy, and xenophobia towards Asian American residents and call on all communities to courageously work together towards healing and recovery.

2. The City of Fresno will look to address the disparity of leadership roles within all City departments, especially in Departments that have daily contact with the community including but not limited to Planning, Purchasing, Public Safety, and more.

3. The City of Fresno will work with community-based organizations in providing safe public spaces for our Asian community members, especially elders, women, and youth, that promote their physical and mental wellness, as well as healing in culturally responsive ways.

4. The City of Fresno will work with community-based organizations to address the systemic barriers to reporting Asian hate incidents through services like languageaccessible hotlines and report data collected in categories disaggregated by ethnicity.

5. The City of Fresno will work with community-based organizations to support community-centered solutions that address public safety in culturally responsive ways for all communities.

6. In consultation with the Asian American collaborative, the City of Fresno will, within 120 days, commit to creating, funding, and staffing a liaison position to Asian American communities and community-based organizations in Fresno whose primary responsibilities will be to implement these commitments.

7. The liaison shall provide a semi-annual report to the Fresno City Council updating the public on the status of the desired outcomes listed in this resolution.

8. This resolution shall be effective upon final approval.

Resolution to Denounce Hate Crimes and Rhetoric Against Asian Americans and Pacific Islanders, and Reaffirm Our Commitment To Ensure API Americans Feel Safe and Welcome

**WHEREAS,** The Asian Pacific Policy and Planning Council and Chinese for Affirmative Action launched a hate incident-reporting internet website, "Stop AAPI Hate," at the beginning of the COVID-19 outbreak in March of 2020; and

**WHEREAS,** The Stop AAPI Hate Reporting Center reported over 2,800 hate incidents against Asian Pacific Islander (API) Americans in 2020; and

**WHEREAS,** Discrimination and racism towards APIs has always existed, such as the 19th century scapegoating of APIs, also known as "Yellow Peril"; and

**WHEREAS**, Racism, hate crimes and negative rhetoric towards APIs has been exacerbated by the COVID-19 pandemic; and

**WHEREAS,** Politically charged and culturally insensitive language referring to COVID-19 as the "Chinese virus" or "kung flu" further encouraged racism, prejudice and hate crimes towards APIs; and

**WHEREAS,** The promotion of such language by the former President Donald Trump during his term further propagated anti-API sentiment in light of COVID-19; and

**WHEREAS**, On January 31, 2021, three elderly Asian Americans were assaulted in the City of Oakland's Chinatown District, including a 91-year-old Asian man who sustained serious injuries, such as lacerations, abrasions, and a contusion to the left thumb, in what is deemed a hate crime; and

**WHEREAS,** On January 30, 2021, 84-year-old Vicha Ratanapakdee, a nearly-blind and gentle elderly Thai man, died from injuries resulting from an attack while he was walking in the City of San Francisco, in what is deemed as a hate crime; and

WHEREAS, About 31 percent of Asian Americans report having been subject to discrimination since the beginning of the COVID-19 pandemic, according to a Pew Research Center report; and

**WHEREAS**, Asian Americans in the State of California are increasingly concerned about their safety and well-being, given the rise of hate crimes and other racially motivated attacks; and

**WHEREAS,** Asian Americans in the State of California are more concerned about the safety of themselves and their families that are currently at high risk of being targeted; and

**WHEREAS,** In 2020, the California State Legislature's API Legislative Caucus spoke out against anti-API hate crimes in an effort to stand up for immigrant and refugee individuals; and

**NOW, THEREFORE BE IT RESOLVED,** that the Monterey County Board of Supervisors, on behalf of the County and all residents thereof, denounce hate crimes, hateful rhetoric and hateful acts against Asian Americans and Pacific Islanders, and reaffirm our commitment to ensure that API Americans feel safe and welcome, both during this COVID-19 pandemic and beyond; and **FURTHER BE IT RESOLVED,** that the Clerk of the Board of Supervisors transmit copies of this resolution to Governor Gavin Newsom, U.S. Senators Alex Padilla and Dianne Feinstein, Congressmember Jimmy Panetta, State Senators Anna Caballero and John Laird, State Assemblymembers Robert Rivas and Mark Stone and the Japanese American Citizens League (JACL) Chapters of Monterey County.

### A PROCLAMATION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE STANDING FOR JUSTICE, PEACE, AND INCLUSION AND DENOUNCING ALL ACTS AND FORMS OF HATE, RACISM, INTOLERANCE, AND VIOLENT EXTREMISM

**WHEREAS,** In 2020 the City of Placerville saw a big increase in the number of political protests and demonstrations, instances of overt racism, complaints from the public, incidents reported to police relating to racism and extremism; and

**WHEREAS,** The City spent numerous hours/dollars in Police overtime, and City Staff time in response to the increasing political and ideological polarization; and

WHEREAS, These displays and demonstrations severely strain the City's limited resources; and

**WHEREAS,** The City values and welcomes all people regardless of race, political views or other personal beliefs; and

**WHEREAS,** The City denounces all acts and forms of hate, racism, intolerance, and violent extremism in Placerville; and

**WHEREAS,** The City of Placerville, including the Placerville Police Department, serves all residents and visitors regardless of their race, political views or other personal factors and will treat all with respect and civility; and

WHEREAS, Protection of constitutional rights by City officials and law enforcement for all shall in no way be construed as supporting, encouraging or agreeing with any particular political, ideological or extremist group:

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PLACERVILLE HEREBY PROCLAIM AS FOLLOWS:

- 1. We stand for Justice, Peace, and Inclusion for all in the City of Placerville.
- 2. We denounce all acts and forms of hate, racism, intolerance, and violent extremism.
- 3. The City of Placerville and the Placerville Police Department invite other jurisdictions, community organizations and clubs to adopt this resolution so we may come together as a community to show a unified front against Racism, Hate, Intolerance, and Extremism.
- 4. We recognize the right of all to free speech and to gather, and we recognize that these constitutional freedoms from persecution do not grant freedom from the responsibility we have to each other. We call on our residents,

visitors, businesses, and event organizers to recognize the harm that outward displays of ideology cause our businesses and community at large and request that people voluntarily choose to leave their affiliation to these groups at home when visiting downtown Placerville for the good of the community.
